# **OXFORD MODEL FLYING CLUB – DATA PROTECTION PRIVACY NOTICE**

At Oxford Model Flying Club, hereafter referred to as "OMFC", we are committed to protecting and respecting your privacy. Our Data Protection Compliance Manager has overall responsibility for data protection compliance in our club. Contact details are set out in the "Contacting us" section at the end of this privacy notice.

This notice explains when and why we collect personal information about people who join the club by whatever means, how we use it, the conditions under which we may disclose it to others and your rights in relation to your personal data.

We may change this notice from time to time so please check the website at <u>www.oxfordmodelflyingclub.org.uk</u> to ensure that you're happy with any changes. Paper copies may be provided on request. By becoming a member of OMFC, you are agreeing to be bound by this notice.

### How do we collect information about you?

We obtain information about you when you apply to become a member of the club, when renew you membership, via the internet, by telephone, or in person.

#### What type of information is collected about you?

The personal information that we collect is your name, address, e-mail address, telephone number, age and gender. The legal basis for the processing of your personal data is to enable OMFC to provide its membership services.

### How is your information used?

We may use your information to:

- Process your membership;
- Carry out our obligations arising from your membership;
- Seek your views or comments on matters relating to the club and model aircraft flying;
- Notify you of changes relating to the club;
- Send you communications which you have requested and that may be of interest to you. These may include information about club events and contests and other club related matters, and also information from the BMFA that may be of interest.

### How long do we retain your information?

We will hold your personal information on our systems for as long as is necessary to carry out our obligations in relation to your membership, or as long as is set out in any relevant agreement between us. Where an individual person's club membership lapses your information will be securely kept for a period of 2 years, after which your information will be deleted.

### Who has access to your information?

We will not sell or rent your information to third parties and we will not share your information with third parties for marketing purposes.

All members of OMFC club must also be members of the BMFA. By joining OMFC you give consent for your personal data to be shared with the BMFA to enable provision of BMFA membership services. Please see the BMFA privacy policy at <u>https://www.bmfa.org/Privacy-Policy</u>

Please note that we will not release your information to third parties beyond the club unless we are required to do so by law, for example, by a court order or for the purposes of prevention of fraud or other crime.

### How you can access and update your information?

### What are your rights?

(a) The right to access:

You have the right to confirm whether or not we process your personal data and, where we do, to access that personal data together with certain additional information. That additional information includes details of the purposes of the processing, the categories of personal data concerned and the recipients of the personal data. Providing the rights and freedoms of others are not affected, we will supply to you with a copy of your personal data.

(b) The right to rectification:

You have the right to have any inaccurate personal data about you rectified and, taking into account the purposes of the processing, to have any incomplete personal data about you completed.

(c) The right to erasure:

In some circumstances, you have the right to the erasure of your personal data without undue delay. Those circumstances include: (1) the personal data being no longer necessary in relation to the purposes for which the data was collected or otherwise processed and (2) you are no longer a club member and wish the data not to be held for our standard 2 year period. Please note a request for data erasure for a current member would require that member to forfeit membership. The data is required for the club to fulfill its obligations.

(d) The right to restrict processing:

In some circumstances, you have the right to restrict the processing of your personal data. Those circumstances are as follows: you contest the accuracy of the personal data; processing is unlawful but you oppose erasure; we no longer need the personal data for the purposes of our processing, but you require personal data for the establishment, exercise or defence of legal claims; and you have objected to processing, pending the verification of that objection. Where processing has been restricted for these reasons, we may continue to store your personal data. However, we will only process it in the following circumstances: with your consent; for the establishment, exercise or defence of legal claims; for the protection of the rights of another natural or legal person; or for reasons of important public interest.

(e) The right to object to processing:

You have the right to object to our processing of your personal data for direct electronic communications purposes. If you make such an objection, we will cease to process your personal data for this purpose.

(f) The right to data portability:

You have the right to receive your personal data from us in a structured, commonly used and machine-readable format. However, this right does not apply where it would adversely affect the rights and freedoms of others.

(g) The right to complain to a supervisory authority:

If you consider that our processing of your personal information infringes data protection laws, you have a legal right to lodge a complaint with the Information Commissioners Office. *https://ico.org.uk* 

(h) The right to withdraw consent.

To the extent that the legal basis for our processing of your personal information is consent, you have the right to withdraw that consent at any time. Withdrawal will not affect the lawfulness of processing before the withdrawal.

You may exercise any of your rights in relation to your personal data by written notice to us.
